

### **CHAPTER 2(MANUAL -1)**

## Particulars of Organization, Functions and Duties

The Directorate of Sports and Youth Affairs was created in the year 1985, bifurcated form the Sports Cell of the DPI to accelerate faster development and promotion of Sports and Games and youth development alongside the creation of necessary sports infrastructure required for grooming, nurturing and channelizing the young potentials for full realization of young individual potential and thereby contributing to human resources – development, of the state and becoming the assets to the society. Sports contribute to the personal development, especially youth development, community development, health and wellbeing and developed the overall personality of the individuals. Sports and Youth activities aim at honing the skills of young athletes, sport talent at the grassroots level, provide support for grooming and nurturing promising children. The Directorate organized Sports and Youth activities from the Block, District Level, State-Level for further participation at the State, Regional, Zonal, National Level and International level with an aim to encourage the Athletes and Youths of the state to achieve their goal be it Sports or Youth activities. Many projects have been taken up all over the state and many ongoing project are under construction which is expected to give more impetus for its infrastructure requirements.

Besides promoting sports and games in the State, the Directorate also provides grants to Meghalaya State Olympic Association, State Sports Association, District Sports Association, Sub Divisional and many clubs and Educational Institutions and NGOs to organize Sports competitions throughout the state. State championship is organized by State Associations for which liberal grants are being extended.

The District Sports Officers promote sports activities and youth affairs in the District. They regularly organize various competitions/tournaments from Block level till the District level and spotted talented athletes and further impart coaching camp on a daily basis in all the Districts. Intensive coaching is always taken up before participation in major competitions/tournaments outside the state.

The Directorate of Sports and Youth Affairs also take up programs to empower the youths, inculcate leadership quantities, exchange culture and traditions and participation at National integral camps. Programmes like Youth Exchange program, Youth festival, youth camps, debate, quiz, extempore, entrepreneurship programmes etc. are activities to broaden the mental horizon and empowerment of the youth in the state.

The scheme YESS! Meghalaya is a holistic initiative established to connect with the Youth of the State. The scheme remains open to all Youth organization in a structured format available online

Promotion of Adventure is another dimension of youth development where State Association is encouraged to take up adventure activities in the State as well as participation in competitions outside the state.

Cash Award: The scheme aims to incentivize and recognize the achievements of outstanding sportsperson, encourage athletes for higher achievements and attracting the younger generation to take up sports.

Sports Scholarship: the Sports Scholarship aims to provide financial supports and other benefits to eligible sportsperson to encourage and motivate them to achieve laurels for the State and Nation and also act as inspiring role models for younger generation to take up sports.

Grassroots Centres: Scheme under Mission Football have set up Grassroots Coaching centres across the state. The objective of this initiative is to develop the sport of football. Grassroots Coaching Centres are set up to impart coaching to the young players between the age group of 6-12 years old both boys and girls.

## **CHAPTER 3 (MANUAL-2)**

## **Power and Duties of Officers and Employees**

**A. Director**: The Director exercises all powers as delegated in its day to day functioning to all other officers and supports staff who are working under the supervision and order of the Director.

The following plans and programmes are being implemented by the Directorate of Sports and Youth Affairs.

- 1. Budgeting for the Directorate and the District Offices.
- 2. Preparing of Governor's address/Finance Ministers/Independence Day/Republic Day speeches.
- 3. Achievement Reports/Review of various schemes, all establishment matters, retention and creation of posts, Allotment of funds to District Offices, Audit Reports and attendance to objections.
- 4. Construction of Indoor/Outdoor stadium and development of existing of playfields/courts/pools etc.
- 5. Assistance of grants for conduct of tournaments to State/District/Sub-Division and other clubs and institutions.
- 6. Assistance of grant for procurement of Sports materials to various clubs, Associations etc.
- 7. Financial Assistance and participation of State teams outside the state including imparting of coaching/trainings.
- 8. Conduct of various Inter Schools Tournaments and Youth Affairs related Programmes like Youth Exchange Programme, National integration camps, Youth Festivals, Debate Quiz, Extempore etc.
- 9. Grants are also extended NGOs/Organization taking up youth development and empowerment programmes.
- 10. Organizing coaching camps all over the state and deputation of available coaches to Association/Institutions.
- 11. Grants to the State Sports Council of Meghalaya for taking up for creation of infrastructure like Indoor/Outdoor stadiums, etc.
- 12. Grants are also given to Association/Clubs/Institutions for improvement of existing playfields/Courts etc.
- 13. Grants for procurement of sports materials to schools/clubs/associations.

- 14. Grants for taking up Adventure sports, trekking, caving explorations etc.
- 15. Fund to Deputy Commissioners under Chief Minister Youth Development Schemes (CMYDS) to take up program depending on local based needs.
- 16. Fund to each Legislative Assembly Constituency is also released to all Deputy Commissioners to implement programme approved by the Govt under the Intensive Youth Development Programmes (ISYDP) schemes.
- 17. Schemes and proposals under NEC/SCA schemes is taken up through the Department of Sports and Youth Affairs and Planning Department.
- 18. Networking with the Govt of India, Ministry of Youth Affairs and Sports & SAI to undertake programme of various schemes which are taken up on an annual basis.
- 19. Eligible candidates are being provided with financial assistance by the Department for undergoing studies in Physical Education, Diploma in coaching in various institute across the country.
- **B.** <u>Deputy Director</u>: He/She may function under overall supervision of the Director, with the specific task of implementation of Khelo India Scheme in the state and also designated as Nodal Officer for Khelo India Scheme.
- C. <u>Assistant Directors:</u> He/She may function under overall supervision of the Director. He is the Nodal Officer designated as Public Information Officer under the Right to Information Act and receive application for information from member of the public and provides information as sought for Co-ordinates the function and programme of the Directorate including Planning for programmes, budgeting and assist the Director on all matters pertaining to administration, monitoring etc at the Directorate Level. Ensures the programmes are implemented with accountability at administration, monitoring etc. Ensures that programme are implemented at District level by District Sports Officers and various clubs/Associations that are receiving grants from the Directorate of Sports and Youth Affairs.
- **D.** <u>Sports Officer:</u> Functions under the overall supervision of the Director specific tasks to monitor sports programmes, coaching, training and tournaments are assigned. Assists the Director in the planning, implementation and monitoring of programmes under the Directorate of Sports. He/She is also a designated Assistant Public Information Officer under the Right to Information Act.

## E. Coaches (Junior and Senior Coaches)

- 1. To impart coaching in their respective specialized discipline sports.
- 2. To officiate in various sports competition organized by the Directorate of Sports & Youth Affairs and District Sports Offices.
- 3. Coaching /Accompanying state teams for Regional and National Competitions

**F. Superintendent**:-.Over all supervision of the assistants under his/her control.
